### **DETAILED SCOPE OF WORK**

# **PPP Application Consulting Services:**

## **Basic Service:**

Serve as consultant to Client relating to preparation and submission of an application for forgiveness of a PPP First Draw or PPP Second Draw loan following the covered period of the PPP loan:

## Forgiveness Application Support Services:

- 1. Up to one-half hour of advisory support by telephone related to best practices counsel and possible strategies for the forgiveness process.
- 2. Provide Client with a required documentation checklist to complete and forward to Armanino for our use in preparing your application for forgiveness
- 3. Receive and input Client payroll and expense data into Armanino's proprietary PPP loan forgiveness calculator:
  - a. Documentation of full-time equivalent employees during covered period
  - b. Documentation of covered payroll costs, mortgage interest payments, other debt interest payments, rent payments, utilities expenses, covered operations expenses, covered supplier costs and covered worker protection expenses
- 4. Prepare forgiveness calculation analysis and review with Client
- 5. Complete lender's forgiveness application request and route to Client for electronic signature
- 6. Submit application and supporting documentation to lender for forgiveness review and decision

PPP application, depending on the scope of the Services hereunder. You affirm that any documents you provide to Armanino in relation to the Services shall be true, accurate and identical copies of those you submitted to the IRS or other governmental authorities. You acknowledge that the SBA and potential lenders will make their own determinations and calculations regarding your eligibility for forgiveness of the PPP loan and no outcomes can be promised, assured or guaranteed by Armanino. Armanino makes no guarantee regarding the outcome of your forgiveness application and shall have no liability if forgiveness of the loan is not granted (partially or fully) for any reason, including, but not limited to, depletion of available federal funds.

A successful working relationship requires a significant commitment on our part, as well as yours. You are responsible to be available during our ongoing work with you, provide timely responses to questions and calls for decisions, and devote the resources necessary to achieve the objectives of the engagement.
